Thank you Mr. Montague for your message left on my answering machine several days ago.


I have not contacted you because the rules of the Law Society of Upper Canada say that if a person has a lawyer, opposing counsel should not communicate with them directly. Your message makes it clear that Mr. Calvin S. Martin Q.C. does not represent you.

Please find attached a motion for substituted service. That, as well as the motion for a preservation order, is scheduled to be heard in Court in Kenora on October 5, 2005.

I would strongly suggest that you seek and retain legal counsel to deal with this matter, as the potential result of this case is the forfeiture of the property.

You may wish to consider requesting a stay of the civil case pending the completion of the criminal case. I would consent to a stay pending the completion of the trial and any appeals that there might be. I can appreciate the fact that defending a criminal case may require all of your attention and that adding a civil case would distract you from some very serious issues.


Re: civil action to seize our home.

William Bruce Montague was found not guilty of trafficking firearms and there was no charge relating to organized crime against us.


Our guilty convictions relate entirely to our protest against Bill C-68 – the Firearms Act. As I am sure you are aware.

We have our bank statements that show our cash flow back to 1996 when we started constructing our home. This shows income from my fathers' estate and my workplace going into our account, and the money going out to paying the invoices for building our home. We also have all the invoices related to building our home as we were preparing to file for the homeowners GST rebate. Unfortunately the seizure of our computer and records put us past the due date to submit for this rebate. This all took place prior to 2002 when the legislation you are using was enacted.

We are requesting that you drop the civil suit to seize our home and remove the lien on our home.



Your letter dated February 26, 2008 was received in our offices today.

As you are unrepresented, according to your letter, I shall communicate with you directly. At the point at which you are again represented please let me know and pass on all communications to that lawyer.

You have been convicted of a multitude of offences. Even though you were acquitted of some charges, for the purposes of civil litigation that does not stop the Attorney General proving the offences on a balance of probabilities.

If you recall, on the return of the motion to preserve your property, I suggested on behalf of the Attorney General of Ontario that you might consider asking for a stay of proceedings until you had finished your criminal matters as you were challenging the

constitutionality of firearms legislation. I also said that if you made that request of the court I would agree on behalf of the Attorney General so that you could deal with one case at a time. You and your counsel at the time took up the offer and the case was stayed until you have finished your appeals in the criminal matter.

The Attorney General is always prepared to review its cases based on new information. However, I first should ask, have you decided against any appeals of your criminal convictions? If you are not pursuing any appeals, I will review the case, and any information you chose to share with the Attorney General, keeping in mind that there is currently a proceeding to seek forfeiture of the property noted above.

If you are appealing your convictions then we will wait until you have exhausted your appeals to re-open this case.
